2. Matters arising

Problems with the delivery of leaflets and possible recovery

We have paid for the leaflets promoting the consultation to be distributed to about 7,500 homes around Bridgnorth. Some areas have not been delivered to at all and other areas seem to have been delivered to incompletely.

We discussed how to proceed in the light of this. It was agreed to:

• Review the situation in the light of how many people attend the next public meeting on Thursday and the results of the email check that Clive is carrying out.

Consultation meetings

The first public meeting, held on Thursday 16th January at Castle Hall, went well but was poorly attended. About 25 attendees in total.

The next two public meetings are:

3. How to progress other areas during 2020

We discussed how to complete sections of the Bridgnorth Plan for those working groups that have already carried out a lot of work. For some, the remaining activity will be to write up their work, in light of the results of the consultation. For others, such as Retail, Hospitality and Tourism, there is more work to do.

Action 20/1-1: Clive Dyson to produce a draft document covering this and suggesting a target date by when draft documents should be completed

We discussed how to progress the other issues previously identified. We agreed to aim to facilitate the issues being addressed by existing groups wherever possible, rather than setting up completely new initiatives. After some debate, we provisionally agreed to start by trying to progress the following:

- Mike Goldsmith to raise environmental sustainability with Sustainable Bridgnorth, with the support of Gary Timmins and Clive Dyson.
- Clive Dyson to progress Crime and Safety (including all the emergency services).
- Darren Hodson to consider how to structure to work on Demographics, to provide a lead in to work on Housing, Medical and Health and support for the young and old.
- Clive Dyson to contact individuals working to support the young and old (Social Sustainability) and enquire how they consider we should proceed on this.

We noted that the survey will provide lists of people willing to contribute to each area.
